Required before the 1st day of EC2:

Required before the 1st day of Kindergarten:

- All of the those required for EC2 PLUS
 - DTap 5th dose
 - IPV 4th dose
 - MMR 2nd dose
 - Varicella 2nd dose

Required before the 1st day of 7th Grade:

- All of the those required to date **PLUS**
 - Tdap Booster 1 dose

Please note: you are welcome to consult with your doctor and spread out/split the immunizations however you see fit, so long as they are complete as indicated above and on the timeline provided.

For those moving from another state or country: Please review the requirements carefully to be sure your child is complete in accordance to the FLORIDA DEPARTMENT OF HEALTH. Requirements may vary between states and countries.

For new applicants: Please be sure your child is up to date and a current immunization is received <u>at the time of the application</u>. The admissions team will review the immunization record and **will not** process or move forward with the application porcess if it is not compliant with ALL the above mentioned requirements.

Please know that Katz Hillel Day School does not accept religious or conciencious exemptions to these vaccine requirements. Medical exemptions must be received for each vaccine individually and will need to be reviewed and approved by our medical task force BEFORE we can move forward with the application process.
